ORDER

The Kansas State Board of Healing Arts ("Board"), by its Executive Director, Susan Gile, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, and upon due consideration of the agency record, the applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

Final Order

1. On December 4, 2019, the Board issued a Final Order against Michael McDonald, P.A. ("Licensee"): (a) assessing a \$100.00 fine; and (b) indefinitely suspending Licensee's Kansas physician assistant ("P.A.") license until Licensee provides proof of payment of the Kansas Health Care Stabilization Fund ("KHCSF") premium surcharges required under K.S.A. 40-3404.

Motion to Terminate Suspension

2. On or about July 28, 2025, Licensee filed a Motion to Terminate Suspension ("Motion") seeking an order: (a) to terminate the indefinite suspension issued by the December 4, 2019,

Final Order; and (b) reinstatement of Licensee's Kansas P.A. license.

3. As of the date of this Order, no response to Licensee's Motion has been filed with the Board.
4. Licensee states since receiving notice of the Board's 2019 suspension, Licensee has not practiced as a P.A. and seeks to make application for reinstatement of his Kansas P.A. license. Motion Exhibit D, pp. 2-3.
5. The Board's Website Licensee Profile Index (Kansas Board of Healing Arts - Licensee & Registrant Profile Search) lists Licensee's Kansas P.A. license as last being renewed on January 31, 2019 and "Cancelled – Suspended" on February 1, 2020. Official notice of this information is taken under K.S.A. 77-524 and K.S.A. 60-409.

Application to Reinstate License

6. As noted in the Motion, in addition to filing the Motion in this matter, Licensee also submitted for filing an application for reinstatement of his Kansas P.A. Licensee ("Application").
7. On or about August 29, 2025, the Application submitted for filing in this matter was hand delivered to the Board's Licensing Department for filing and processing.

Order

The request to reinstate Licensee's Kansas P.A. license is not addressed in this Order and is a separate matter to be considered properly upon Licensee's Application being deemed complete and ready to be reviewed for compliance with the Kansas P.A. licensing requirements. This Order does not consider or take any action regarding Licensee's Application

other than delivering the Application to the Board's Licensing Department.

Licensee's Kansas P.A. license was cancelled on February 1, 2020. The time to terminate suspension of that license expired on the same date the license expired (February 1, 2020). As Licensee does not currently hold a Kansas P.A. license, any decision addressing termination of the indefinite suspension of Licensee's prior Kansas P.A. license is moot.

Licensee's Motion to Terminate Suspension is **DENIED** for mootness as stated above. As Licensee's application for reinstatement of his Kansas P.A. license has not been deemed complete, this Order **DOES NOT CONSIDER** nor take action on: (a) Licensee's Application; or (b) the Motion's request to reinstate his Kansas P.A. license.

IT IS SO ORDERED.
