ORDER REINSTATING LICENSE AND LIFTING SUSPENSION

NOW on this 10th day of October 2025, comes on for hearing before the full Kansas State Board of Healing Arts (Board) the Motion to Lift Suspension filed by the Licensee, Angela C. Shaw, D.O. (Licensee). Licensee appears by and through counsel, Mark A. Lynch, and in person. Tammie L. Mundil appears as Disciplinary Counsel and prosecutes the matter before the Board. There are no recusals. The Board FINDS and ORDERS, the following:

1. Licensee submitted her application to renew her doctor of osteopathy license on October 29, 2024.
2. Licensee's answered "yes" to a question on the application that triggered the Board's need to review additional information.
3. The Board's requests for the needed information went unanswered necessitating the filing of a summary order on June 23, 2025. The summary order proposed suspension and gave Licensee an opportunity to respond prior to suspending

her license if she requested a hearing or complied within 15 days of the date of service of the summary order thereby mooting the need for a hearing.

4. When no response or request for a hearing was received the summary order became a final order on July 18, 2025.

5. Licensee submitted a completed questionnaire and requested reinstatement of her license on July 18, 2025.

6. On July 24, 2025, Disciplinary Counsel notified the Board by Email that she objected to Licensee's request for reinstatement because requested information had not been submitted in full.

7. Later that same day on July 24, 2025, Disciplinary Counsel advised the Board, again by email, that the information had been provided.

8. On July 25, 2025, Licensee formally moved to lift the suspension, and the matter was set on the next available Board docket on October 10, 2025.

9. Licensee advises the Board that she had been mistaken when she failed to provide the requested information regarding her 2024 renewal and that it would not happen on future renewals.

10. With the aforementioned assurances from Licensee, the Board LIFTS THE SUSPENSION of her 2024 Licensee and REINSTATES her 2024 license to practice osteopathy in Kansas.

This reinstatement applies only to the 2024 license renewal that expires on October 31, 2025, and applies only to the issue of the failure to provide the information requested in renewing the 2024 license. Other matters that may or may not require investigation or discipline are not before the Board at this time in this matter.
