FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW on this 31st day of October, 1992, comes on for Conference Hearing before the Kansas State Board of Healing Arts (hereafter "Board") sitting as a whole the request for extension of institutional license filed by Norma I. Carrillo, M.D. (hereafter "Licensee"). Licensee appeared in person. Also appearing on behalf of Licensee were Doug Martin, attorney for Mental Health Consortium and three representatives from Larned Correctional Mental Health Facility.

After reviewing the request, hearing statements and arguments of Licensee and counsel for Mental Health Consortium and being otherwise duly advised in the premises, the Board finds as follows:

1. K.S.A. 1991 Supp. 65-2895 provides that an institutional license may be issued by the Board and sets forth the criteria under which said license may be issued.

2. K.S.A. 1991 Supp. 65-2895(b) provides that an institutional license shall be valid for a period of two years

after the date of issuance and may be renewed if the Applicant meets the requirements set forth in said subsection.

3. On October 29, 1990, Licensee received institutional license number 8-00226 which expired October 29, 1992 pursuant to the provisions of K.S.A. 1991 Supp. 65-2895(b).

4. On or about April 6, 1992, Licensee changed her employment from Larned State Hospital to Mental Health Consortium which is a third party that has a contract with the Department of Corrections to provide medical care at the Larned Correctional Mental Health Facility.

5. Performance evaluation dated October 6, 1992 indicates Licensee to have been rated excellent in all categories and by letter received in the Board office October 22, 1992, Licensee has been considered by Mental Health Consortium and Larned Correctional Mental Facility to be virtually irreplaceable.

6. Licensee has not successfully completed the examination required under subsection (a)(3) of K.S.A. 65-2873 and amendments thereto as required by K.S.A. 1991 Supp. 65-2895(b) so as to enable the institutional license issued to her October 29, 1990 to be renewed under the provisions of that subsection.

7. Licensee should undergo an assessment of her psychiatric skills in the setting in which she is presently employed by two psychiatrists appointed and approved by the Board within thirty (30) days following service of this Order upon Licensee.

8. Action on Licensee's request for extension of institutional license number 8-00226 should be continued and tabled pending receipt of a report from the two psychiatrists appointed to assess Licensee's psychiatric skills to practice at Larned Correctional Mental Health Facility.

9. In the event the report from the two psychiatrists appointed by the Board to assess Licensee's psychiatric skills deems such skills to be satisfactory to practice psychiatry at Larned Correctional Mental Health Facility, action on the request for institutional license should be continued and tabled until the next regularly scheduled meeting of the Board following receipt of the results of the FLEX II examination to be administered in June 1993, said date tentatively anticipated to be August 14, 1993.

10. That cancellation of Licensee's institutional license number 8-00226 should be stayed pending receipt of the report from the two psychiatrists as above stated and, in the event a satisfactory report is received, further stayed until the next regularly scheduled meeting of the Board following receipt of the results from the June 1993 FLEX examination.

IT IS THEREFORE BY THE BOARD ORDERED:

a. The Findings hereinabove made be and the same are hereby made the Order of the Board.

b. That institutional license number 8-00226 originally issued October 29, 1990 to expire October 29, 1992 be extended and remain valid and in full force and effect until the date hereafter established.

c. Licensee shall undergo an interview and assessment of her psychiatric competency to practice at Larned Correctional Mental Health Facility by two psychiatrists appointed by the Board within thirty (30) days of service of this Order upon Licensee.

d. In the event the assessment and report from the two psychiatrists appointed by the Board proves satisfactory, action on Licensee's request for extension of license should be continued and tabled until the next regularly scheduled meeting of the Board following receipt of the results of the administration of the FLEX II examination to be given June 1993, said date anticipated to be August 14, 1993 and that said institutional license remain in full force and effect and be valid until such time.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
