FINAL ORDER TERMINATING CONSENT ORDER

NOW on this 14th day of October, 2016, comes before the Kansas State Board of Healing Arts ("Board") the request filed by Thomas Hegarty, M.D. ("Licensee") to terminate the monitoring requirement contained in his Consent Order. Licensee appears in person, and *pro se*. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Board.

Pursuant to the authority granted to Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, receiving exhibits into evidence, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Licensee is licensed to practice medicine and surgery in the State of Kansas, having been issued License No. 04-36965 on approximately December 13, 2013.
2. On October 4, 2013, Licensee entered into a Consent Order as a condition to being granted temporary licensure in Kansas. Such Consent Order was ratified by the Board and Licensee was granted permanent licensure on December 13, 2014.


4. On August 29, 2016, Licensee submitted a request to the Board to terminate the monitoring requirement of the Consent Order.

5. On September 9, 2016, Associate Litigation Counsel filed a response which detailed Licensee's compliance with the monitoring provision of the Consent Order.

6. The Board finds and concludes that Licensee has satisfactorily complied with the monitoring provisions of the Consent Order and that termination is warranted under the circumstances.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Licensee's request to terminate the Consent Order is hereby **GRANTED** and Licensee shall have no further obligation for compliance.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service, and service of a Final Order is complete upon mailing. Pursuant to K.S.A. 77-529, Licensee may petition the Board for Reconsideration of a Final Order within fifteen (15) days following service of the final order. Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order.
